## Mission

Support Act Limited is a registered charity and non profit organisation which raises funds to provide relief arising from hardship and/or illness amongst those working in the Australian music industry and is the only benevolent fund for this purpose.

## Bequest Information

If you would like to leave Support Act a gift in your Will or should you decide to include Support Act as a beneficiary, there are a number of ways to do so. Support Act recommends that you obtain independent and professional advice from a solicitor to ensure that your Will is valid and your wishes carried out.

Support Act was established in 1997 and is a company limited by guarantee (ABN 43 079 588604). Its annual financial reports are available for download at [www.supportact.com.au](http://www.supportact.com.au) or call 02 9332 4424 to request a copy. Its financial auditors are KPMG (Sydney), and its lawyers are TressCox Lawyers (Sydney). Please contact Support Act for any further information.

If you do already have a Will, you can update this with a codicil. This is an extra clause to include your bequest. If you don't already have a Will, there are three options to consider if you would like to provide a bequest to SAL:

1. Residuary Bequest – means a Bequest of the residue of an estate
2. Specific Bequest – means a Bequest of a specific and severable asset or right. This may include property, shares or royalties.
3. Pecuniary Bequest – means a Bequest of a specific sum of money.
